Second Recall of Robin Vos Picks up Steam

[Racine County, Wisconsin]—May 3, 2024

Mike Lindell traveled to Kenosha, Wisconsin on Wednesday to show support for the people of Wisconsin and the grass-roots effort to recall Speaker of the Wisconsin House **Robin Vos** at a rally for **Donald J. Trump**.

“The people of Wisconsin were amazed at how far a treacherous politician would go to avoid being recalled in his district,” according to Lindell. “Robin Vos, a so-called Republican, used his authority to literally redistrict in the middle of a recall against him! This caused thousands of signatures needed to remove him from office to be thrown out! Can you imagine the audacity to change boundaries and use your influence in the legislature to keep your position? That’s exactly what Robin Vos did.”



Vos, who stated in 2022 that he would work “as hard as I can to make sure Donald Trump is not the nominee,” has repeatedly thwarted efforts to secure elections in Wisconsin, including protecting Wisconsin Elections Commission Administrator **Meghan Wolfe**, in violation of Assembly Rules, after the State Senate approved a resolution to impeach her.



Wisconsin has been rife with highly questionable and unethical election practices under Wolfe, igniting multiple legal challenges, an impeachment inquiry into Wolfe, and the Vos recall efforts. The [Gateway Pundit reported](#) at least four specific instances of election malfeasance by Wolfe:

- Wisconsin Supreme Court rules 2020 election results are “illegitimate” because the Administrator of Elections harmed and injured voters by not following the law ([Drop boxes are illegal in Wisconsin, state’s high court rules](#)).
- Court rules it’s illegal for Administrator of Elections to advise Clerks to “cure” absentee ballots in 2020 ([Wisconsin ruling blocks curing absentee ballots](#)).
- Judge outlaws illegal voter registration form Administrator of Elections has been using for years ([Judge blocks Wisconsin officials from using federal voter registration form](#)).
- Racine County Sheriff investigation shows evidence of election fraud at long-term care facilities based on advice of the Administrator of Elections ([Racine Co. Sheriff alleges elections commission broke the law](#)).

Vos has also come under fire for alleged ties to the Chinese Communist Party (CCP). State **Representative Janel Brandtjen** revealed in an April 29, 2024 media release that, “Speaker Vos participated in at least two trips under the sponsorship of CCP associates.” She further shared that “the most alarming demonstration of potential compromise occurred in 2024 when Speaker Vos influenced the legislative process to obstruct [AB269](#), a bill intended to restrict Chinese ownership of Wisconsin farmland,” adding that, “This decision poses a direct question about whose interests Speaker Vos truly represents.”

Vos’s refusal to prohibit foreign adversaries, including China, from acquiring agricultural and forestry land in Wisconsin likely relates to the fact that he sits on the CCP-tied Legislative Leaders Foundation Board of Directors.



Vos narrowly escaped recall in an initial effort that garnered over 10,000 signatures from his district, after he hired teams to scour signatures and remove as many as possible. Reports of police interference against legal petition gathering, as well as false allegations of non-citizen recall workers—a claim thoroughly refuted by Burlington Police Chief, Brian Zmudzinski—raised suspicion that the rejection of the first recall may have been yet another manifestation of Robin Vos's corrupt stranglehold over his constituents.

But the people of Wisconsin haven't given up on removing a corrupt and compromised politician, as the second recall gains momentum.

"The Lindell Offense Fund will be there every step of the way giving support and needed media attention to this critical recall effort," says Lindell, "making sure this effort is successful, providing volunteers, resources, media and even speaking on the ground this week to the people of Wisconsin, along with our great real President, Donald J. Trump."



We have had some complaints regarding individuals collecting signatures for the recall Vos efforts throughout the community. We have no reason to believe any of them involved illegally employed migrants.

Within the article, it states, *“Several circulators were also found to be circulating petitions among students at Burlington High School without verifying whether the signers were 18 years old”*. To our knowledge, no complaints were ever made to our department from the Burlington High School’s faculty or students reporting this activity. I am not certain where this information came from.

Also, one point I would like to clarify from the article, *“When the officers questioned the circulators, they realized that several of them were not United States citizens and were actually from Mexico and Honduras”*. Several members of the department and I met with the event organizers on February 20th on multiple occasions who were collecting signatures. None of those collecting signatures that day were found to be of Mexican or Honduran descent. Most of them were known local citizens of the Burlington area.
