## GRISWOLD 'LEAKED' COLORADO ELECTION PASSWORDS TO PUBLIC



"We will not tolerate any effort to threaten THE security of our gold standard elections." -Jena Griswold, Colorado Secretary of State (Greenwood Village, CO) According to an affidavit sent to the Republican Party of Colorado, Colorado Secretary of State, Jena Griswold, shared a file on her website that contained over 600 BIO: passwords for voting system components in 63 of the state's 64 counties. On Thursday, October 24, 2024, those BIOS passwords were discretely removed by an unnamed official. A letter from the Colorado GOP has been sent to the Colorado Secretary of State's Office

"We hear all the time in Colorado from Secretary Griswold and Governor Polis that we represent the 'Gold Standard' for election integrity, a model for the nation. One can only hope that by the Secretary of State posting our most sensitive passwords online to the world dispels that myth."

"It's shocking really. At best, even if the passwords were outdated, it represents significant incompetence and negligence, and it raises huge questions about password management and other basic security protocols at the highest levels within Griswold's office," -Dave Williams, Chairman, Republican Party of Colorado
